**BANKRUPTCY COURT FEE SCHEDULE (28 U.S.C.1930)**

Revised 7/2001

**Petition:**            **\$200** (Chapter 7 - includes \$30 administrative fee and \$15 Trustee surcharge)  
                         **\$185** (Chapter 13 - includes \$30 administrative fee)  
                         **\$830** (Chapter 11 - includes \$30 administrative fee)  
                         **\$230** (Chapter 12 - includes \$30 administrative fee)

**Motions to Convert to Chapter 7: \$15 fee (Trustee Surcharge)**

**Motions to Convert to Chapter 11: \$645 fee if case converts from Ch. 7 or Ch. 13 at request of debtor**

**Motions:    \$75 fee**    Motions to terminate, annul, modify or condition automatic stay;  
                                         Motions for withdrawal of reference;  
                                         Motions for abandonment;  
(No fee required for co-debtor's stay; representative for child support creditor, if appropriate form is filed, and U. S. agencies)

**Deconsolidation or Split of a joint case for one debtor to convert: One-half (½) of current filing fee for chapter under which joint case was commenced**

**Adversary: \$150 fee is assessed.**    If a Trustee or debtor in possession is the plaintiff, the fee shall be payable only from the estate and to the extent there is any estate. (No fee required if plaintiff is U. S. agency, debtor or representative for child support creditor if appropriate form is filed.)

**Motion to Reopen:**    Fee is amount of the **filing fee in effect** at time motion to reopen is filed. (No fee is required if reopened to correct administrative error or for actions relating to debtor's discharge.)

**Amendments:    \$20 fee** for amendments to debtor's schedule of creditors or list of creditors

**Appeals or Cross-Appeal: \$100** (docketing fee) and **\$5** (appeal fee) = **Total \$105** (A separate fee shall be paid by each party filing notice of appeal, but parties filing joint notice are required to pay only one fee.)

**Certification of any document or paper: \$7 fee**

**Exemplification of any document or paper: \$14 fee**

**Reproduction of records (copies): \$.50 cents per page (U. S. agencies are **ONLY EXEMPT** for file copies **NOT** computer generated information such as: claims registers, docket sheets, calendars...Representatives for child support creditors are **NOT EXEMPT**.) **\$.10 cents per page** for printing copies of any record or document accessed electronically at a public terminal in the courthouse.**

**Reproduction of recordings: \$20 fee** includes cost of materials

**Retrieval of record: \$35 fee** for retrieval of records from the Federal Archives & Records Center

**NSF Check Fee: \$35 fee** will be assessed for all checks returned due to lack of funds

**Search Fee: \$20 fee** per name or item searched (No fee required if U. S. agency, or representative for child support creditor)

**Filing or indexing: \$30 fee** for filing or indexing any paper not in a case or proceeding for which a filing fee has been paid, including registering a judgment from another district

**Registry Fee:** All deposits made after 12/1/90, all funds invested will be assessed a charge of **10%** of the income earned

**Electronic Access to Court Data: \$.07 cents** per page of usage (Billed by and payable to the Billing Center)

**PAYMENT OF THESE FEES SHALL BE MADE PAYABLE TO THE CLERK, U. S. BANKRUPTCY COURT.**
